



BEACH REGULATION AND INFORMATION NOTE 2020

- Obligation not to access in the event of a quarantine, in the presence of flu symptoms or body temperature above 37.5 ° C or if coming from areas of outbreaks reported by the Ministry of Health;
- a certification by the head of the family will be required upon arrival;
- the body temperature can be detected and access will be prevented in the event of a temperature higher than 37.5 ° C;
- users must wear the mask on arrival until they reach the assigned station and do the same to exit;
- access to the beach must take place in an orderly manner in order to prevent gatherings of people, respecting the interpersonal distance of at least one meter;
- it is mandatory to observe an interpersonal safety distance of at least one meter, both on the beach and during bathing, even during the use of showers; the obligation is waived only for members of the same family or cohabitants;
- each umbrella will have a minimum distance of 10.50 sqm;
- it is possible to have a maximum of 4 sunbeds under each umbrella;
- those who walk along the shoreline must take care to observe the physical spacing measures and limit the lay off;
- use of sunbeds and deckchairs by placing a personal beach towel frequently washed at least at 60 ° C;
- use must take personal hygiene measures, in particular taking care of the frequent cleaning and disinfection of the hands of children as well;
- obligation to shower immediately after bathing with particular care of cleaning hands and face;
- Parental control of children's compliance with all rules of behaviour;
- the equipment will be cleaned and sanitized daily;
- wear masks and gloves according to the regulations in force;
- it is forbidden to exchange equipment among umbrellas;

In order to maintain social distancing and avoid gatherings this year there will not be no games at the beach, the beach volleyball / tennis courts will not be set and the usual activities of children animation and aquagym will not take place.

It will be possible to access the beach from 08.00 to 20.00.

It is possible to download the IMMUNI app by using the free wi-fi regional network.

INTEGRATIVE RULES AND INFORMATION NOTE 2020

The Camping place has to be a safe place both for users, and for those who work there, so we kindly ask you to read carefully, sign for acceptance and respect the following regulation:

- upon arrival, all campers are required to stop at the Reception to communicate their entry;
- obligation not to enter the tourist-accommodation area in the event of a quarantine, in the presence of flu symptoms or body temperature above 37.5 ° C;
- upon arrival at the Camping place, the head of the family must complete a self-certification of good health for the entire family;
- the body temperature can be detected by preventing access in the event of a temperature higher than 37.5 ° C;
- respect the social distance of at least 1 meter, wear a mask and gloves according to the regulations in force;
- obligation to use the mask in indoor spaces (for example: commercial activities, in common areas and in toilets) and in any case always when it is not possible to respect the interpersonal distance of at least one meter (except for those belonging to the same family or people who share rooms for overnight stays);
- use the toilets and showers respecting the safety distance of at least 1 meter and in a staggered manner waiting for the exit of those who come before us;
- children under the age of 12 must be accompanied by parents to the toilets and showers;
- entry is forbidden during the cleaning and sanification of services and showers;
- it is strictly forbidden to create gatherings both inside the campsite and on the beach;
- campers are not authorized to have external guests enter the campsite unless previously authorized by the Management; transgressors will be reported to the competent authorities;
- obligation to lock the beach access gates; access allowed from 6.00 to 24.00;
- all campers are prohibited from entering the facility's private areas of the camping such as warehouses, closets, workshops;
- users must take personal hygiene measures, in particular taking care of the frequent cleaning and disinfection of the hands of children too;
- the occupants of the pitches are advised to clean and disinfect the external furnishings as well as the internal ones;
- parental control of children's compliance with all rules of behaviour;
- follow the rules of the beach;
- Respect the bar-restaurant regulations; the restaurant will guarantee take-away service and delivery to the pitch or bungalow;
- follow the market rules;
- in the event that a guest has fever and symptoms of respiratory infection (dry cough, fever, sore throat, breathing difficulties) he must immediately communicate it to the owner of the structure who will promptly inform the competent health authority (by contacting the emergency numbers for Covid 19 indicated by the Marche Region), pending the arrival of the sanitary workers in order to minimize the risk of contagion, the guest will be made to wear a surgical mask, will be directed to his room or to an isolated environment with the door closed, ensuring adequate natural ventilation.

The Management implements all the conditions for compliance with the rules and behaviours of these guidelines without however being directly responsible for any contrary conduct by individual customers.
